**Program Goal # 1: CONSERVATION OF THE NATURAL ENVIRONMENT****Objective 1:**

**To support integration of ecologically sensitive practices in decisions on use of private and public lands in and adjacent to Crowsnest Pass**

**Outcomes**

- Reduction of human/wildlife conflicts
- Implemented/improved environmental protection for key natural areas
- Inclusion of conservation principles in future community and economic development

**Action Plan**

- Continue to support the development and delivery of the WildEd program
- Provide constructive input to relevant decision makers on adherence to ecological principles in regards to proposed industrial, infrastructure, and resource development
- Monitor, educate and communicate with the community to facilitate informed discussion on land use issues through outreach activities, including e-newsletters, our website, brochure distribution, media coverage and public presentations
- Participate in stakeholder input to the planning and management of Castle Provincial Park and Castle Wildland Provincial Park
- Participate in the Livingstone – Porcupine Hills Recreation Advisory Group to monitor and influence the implementation of the Livingstone – Porcupine Hills Linear Footprint and Recreation Management Plan
- Promote the development of ecologically sound trail systems in Crowsnest Pass in cooperation with other recreational user groups and individuals
- Support and participate in the Roundtable on the Crown of the Continent activities

## **Objective 2: To promote wildlife connectivity in the Crowsnest Pass**

---

### **Outcomes**

- North/south movement of wildlife is maintained or improved with future Highway 3 development
- Protection of seasonally important wildlife habitat adjacent to Highway 3
- Maintain wildlife movement in the areas adjacent and within the Crowsnest Pass

### **Action Plan**

- Provide education to Crowsnest Conservation Society members, supporters and the community through our e-newsletter, our website and media coverage
- Support local projects that provide mitigation measures to protect wildlife at identified hotspots along Highway 3
- Participate in stakeholder consultation regarding the future Highway 3 development in support of wildlife movement through the area

## **Objective 3:**

### **To support measures to improve the health of the local watershed and riparian areas**

---

### **Outcomes**

- Decreased prevalence of invasive plant species within and adjacent to the Municipality of Crowsnest Pass with particular attention to riparian areas

- Increased presence of native trees, shrubs and grasses in riparian areas
- Support the Municipality of Crowsnest Pass' ongoing riparian restoration program
- Protection from development in wetland areas
- Protection and restoration of aquatic biodiversity in our local watersheds, including native fish populations of Westslope Cutthroat and Bull trout

### **Action Plan**

- Work with groups such as the Oldman Watershed Council, Municipality of Crowsnest Pass, Trout Unlimited, Cows and Fish, Chamber of Commerce, and industry organizations to advocate for watershed conservation
- Participate in volunteer weed pulls and replanting events organized by other conservation groups and by the Municipality of Crowsnest Pass
- Continue to organize and participate in community clean-up events
- Engage with all prospective mine companies on watershed impacts due to mining activities

**Objective 1: To promote awareness and enjoyment of the unique natural heritage of the Crowsnest Pass among residents and visitors**

### **Outcomes:**

- Continuation of CCS' year-round birding/nature education activities
- Volunteer participation in community stewardship events
- Education of members and contacts about community recycling programs
- Promote local waste reduction initiatives

- Increased opportunities for community members and visitors to experience our local environment

### **Action Plan**

- Continue to offer a wide variety of activities, including bird counts, hikes and workshops
- Work in partnership with Doors Open and Heritage Committee, Crowsnest Forest Stewardship Society, and other groups in planning many of our educational activities
- Continue to organize and support community clean-up activities, weed pulls and other stewardship events
- In partnership with Wildsight, continue to offer the *Classroom with Outdoors* program to students in Grades 4-6 at Isabelle Sellon School
- Work with community teachers to develop other outdoor education programming
- Work with local youth groups on conservation education opportunities
- Participate in the Chamber of Commerce Annual Life Style & Outdoor Adventure Show
- Continue to distribute CCS' educational brochures and update as needed
- Encourage use of an established and sustainable trail network
- Monitor, educate and communicate with the community to facilitate informed discussion through outreach activities, including e-newsletters, our website, brochure distribution, media coverage and public presentations
